### **AWPCA Exhibitor Information**

AWPCA has 68 booth spaces available for the 2025 Conference. Booth preferences will be handled on a first-come first-served basis. Consideration will be given for your booth space preference; however, regardless of your request, AWPCA reserves the right to assign your booth space as necessary to accommodate all vendors.

Exhibit space is limited, so reserve your booth early to assure your company's representation at the conference, which is attended by over 200 water and wastewater professionals from across the State. Event sponsors are always welcome and will receive recognition.

**Booth Assignments:** Booth spaces will be assigned first-come, first-serve basis, based on the receipt of the following: registration form, Hold Harmless Clause and payment in full. No space will be held based on verbal or written reservation without all forms and full payment in advance. Consideration will be given for your booth space preference; however, regardless of your request, AWPCA reserves the right to assign your booth space as necessary to accommodate all Exhibiters.

**Equipment Provided:** Booth spaces will be 10' wide x 8' deep, available on a first come basis, and will include one (1) 6' draped table, two (2) chairs, one (1) wastebasket, 120-volt power and a small company sign that will be placed on the pipe and drape above your booth. Additional equipment and services can be provided for an additional fee. (i.e., Wi-Fi access and additional power requirements.)

**Exhibitor Exposure:** <u>ALL</u> breaks and lunch on Tuesday, as well as the morning break on Wednesday will be held in the Exhibit Hall to maximize vendor contact with conference attendees. There will also be a "5:00 O' Clock Somewhere" Social in the exhibit hall on Tuesday 4:30 – 6:00PM for attendees and vendors to meet and talk with their beverage of choice.

**Exhibitor Door Prize:** Each Exhibitor is encouraged to provide a door prize. In an effort to get attendees into the Exhibit Hall and keep them there as long as possible, all door prizes will be awarded in the Exhibit Hall.

**Cancellation Policy:** A seventy-five percent (75%) refund of the registration amount will be made only if written notification is received prior to June 30th, 2025. A fifty percent (50%) refund of the registration amount will be made if written notification is received prior to July 31st, 2025. No refunds will be made if notification is received after July 31st, 2025. Refunds will be issued after the conference has concluded, in accordance with the Cancellation Policy.

**Set-up and Tear-down Policy:** Exhibitor display set-up time will be Monday, August 11th, 2025, from 1:00 pm to 5:00 pm. The AWPCA ask that Exhibitors have their booths remain in place until 11:00 am on Wednesday, August 13th, 2025.

**Receiving/Drayage Services:** Convention, tradeshow and/or freight materials shipped to the hotel will be turned over to Wave Audio Visual Productions for storage and handling, and additional fees will apply. Please note, packages cannot be delivered to the exhibit floor until all billing is completed.

Shipments (boxes, packages, etc.) should not arrive at the hotel more than five (5) business days prior to the start of an event or meeting.
